The national Cancer Biology Annual Retreat (CABTRAC 2022), held October 21-22-23, 2022 on Nashville, Tennessee, served 101 member attendees, 26 virtual member attendees, 36 trainees, 2 invited speakers, and 6 National Cancer Institute representatives (total participation 171 persons). The three-day program covered topics including training grants, career development, mentoring, diversity, recruiting, retention, grant writing, CV/resume writing, scientific communication skills, scientific posters, CRTEC, etc.
Note: total 2022 calendar-year expenses and revenue include amounts for the 2021, 2022 and 2023 annual retreats.
